Summary

Health Care Proxy

Document in which patient assigns an agent to make medical decisions for the individual. Choose a good agent since your life is in their hands. It cannot be made if you are incompetent at the time so plan ahead. It can be changed. Organ or Tissue Donation is now a part of the proxy. The hospital can provide you with the form but will not help you fill it out. See an attorney. Automatically is void if your spouse is your proxy and you get divorced.

Living Will

No legal status under law but can be used in the absence of a Health Care Proxy. In the absence of both, then the decision is the families to make. In the absence of family then the medical professionals make the decisions about your care.

DNR: Do Not Resuscitate

Advice given is that you should not sign it until it happens. DNI is do not intubate – used for breathing

MOLST: Medical Orders of Life-Sustaining Treatment

Shared a case where family disagreed about care with no quality of life. Since the patient did not have a health care proxy or living will, that could have identified her wishes, she was kept alive while her family (husband and parents) disagreed for 8 years

What do you do with these documents? You should keep the original in your wallet at all times, copies to Dr, kids, lawyer, the person who is your health care proxy, etc.

Jim Dickson shared that the Tenant of the hospital is to always preserve life.
