- COVID amplified and compounded longstanding challenges i.e., health disparities, racial disparities, mental health, substance abuse, domestic violence, child abuse, older adult abuse, digital divide, skills gap.
- Up to 30% of community-based nonprofits are at risk of insolvency or dissolution
- Five Emerging Nonprofit Trends
 - Equity and Inclusion leading by example and doing the real work
 - Virtual Employee Engagement some employees will never return and workforce is tight
 - Remote work hybrid, flexible work; staffing expectations and new patterns of how, where, and when we work
 - Mental Health and Well-Being staff burnout, exhausted by change, and fear

- Flexibility and "Future Proofing" purposefully build in agility and resilience across all business strategies so that you can adapt quickly to more change.
